Bidding is open to all eligible bidders as per Section V of bidding
- 2. Mai Municipality invites electronic bids from eligible bidders for the Construction of 15 Bedded Hospital Building in Mai Municipality under National Competitive Bidding - Single Stage Two Envelope Bidding

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:
- Minimum Work experience of similar size and nature: Successfully Completion of one Building Projectwithin Last 10 Years with Value of at least Rs. 11,00,00,000.00 (Without VAT)
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
