Pa. 14 Road and Kali Khola Culvert in Mai Municipality 05** under National Competitive Bidding procedures. The estimated amount for the works including VAT and PS is Rs. 1,21,87,284.34.

Bidders, submitting their bid electronically, should deposit the cost of bidding document ( Nrs: 3000.00 ) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or before **12:00 Noon on 2082/11/12**. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **01:00 PM on 2082/11/12** at the office of *Mai Municipality, Sitali, Ilam*. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. **2,70,000.00** which shall be valid for 30 days beyond the validity period of the bid.


