Bid security Amount Should be deposited in Sanima Bank, Dharauti Account (052010020000008). Bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2077/09/12. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives (if attended) who choose to attend at 2077/09/12 at 14:00 pm at the office of Mai Municipality, Office of Municipal Executive, Sitali, Ilam. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format amounting to a minimum amount of Rs.75,000.00 (In Words Seventy Five Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.
