

The estimated amount for the Construction Work is NRS. **37,73,542.30** (Thirty Seven Lakhs Seventy Three Thousand Five Hundred Fourty Two Rupees and Thirty paisa Only.) (including VAT)

1. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site **www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in **Sanima Bank, sanchitkosh account 0520100200000005** in as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Bid security Amount Should be deposited in **Sanima Bank, Dharauti khata 0520100200000008** electronic bids must be submitted to through PPMO website **www.bolpatra.gov.np/egp** on or before 12:00 PM on **2076/11/30**. Bids received after this deadline will be rejected.
3. The bids will be opened in the presence of Bidders' representatives (if attended) who choose to attend at **2076/11/30 at 2:00 pm** at the office of **Mai Municipality, Office of Municipal Executive, Sitali, Ilam**. Bids must be valid for a period of **90** days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum amount of **Rs.97,500.00 (In Words Ninety Seven Thousands Five Hundred Only)**, which shall be valid for 90 days beyond the validity period of the bid.
4. If the last date of purchasing /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
